COR Photo and Social Media Release Waiver Form
COR Swimming Association (COR)

COR Parents / Guardians:

The COR Swim Team (COR) uses social media platforms such as Facebook, Instagram, Twitter and our website to publicize and promote our team and team members. This will include live updates from swim meets, photos from practices, events or swim meets and highlight other areas the COR staff feels appropriate. The COR Coaches will directly approve and post items through our social media accounts. We want to use these platforms to broaden our communication and recognize our swimmers.

Parental or legal guardian consent is required for all athletes under the age of 18 for publishing of any photographs or videos of the swimmers. A parent or guardian has the right to refuse to have their children photographed. The exercise of this right of refusal will not effect the eligibility of the swimmer(s) or families with COR or USA Swimming events. In the case of open meets and other competitions where the host club has an official photographer present, all parents attending should be made aware of this in the event's meet information. If photos are published anywhere, the individual parent will be given the opportunity to withhold consent.

All photographs and videos must observe generally accepted standards of decency to include:

- Action shots should be a celebration of the sporting activity and not a sexualized image in a sporting context.
- Action shots should not be taken or retained where the photograph reveals a torn or displaced swimsuit.
- Photographs should not be taken from behind the swimming blocks at the start of a race or exhibit a child climbing out of the swimming pool.
- Photographs or videos are BANNED and will not be taken in locker rooms or bathrooms.

Accepting and signing will grant COR, the web designer and COR's social media outlets permission to post pictures and/or swimmer's name. COR will only use the photos on our approved accounts. Account links can be found on the COR website (www.corswim.org) or listed below.
